

Leon River Watershed Summary

- 16 stream AU's have now been divided into 2 stream segments.
- RUAA's for Resley, Indian, & S. Leon are at EPA.
- Wildlife is a concern for future delisting's.
- Most stream segments appear to be improving over the last 10 years.



Delisting of Stream Segments


List of successful delisting's and years

- 2012
 - There were 11 AU's listed on 303(d) list
- 2014
 - 7 AU's listed
 - 1221_01, _04, _05, & S. Leon were removed from list.
- 2016
 - Walnut Creek is now SC2 (not official)
- RUAA Acceptance
 - If remaining RUAA's are accepted by EPA, Resley & Indian Creeks <u>could</u> come off the list (4 AU's total).

Overall Septic Performance

• Leon River WPP recommended that 120 systems be identified and replaced between 2010-20.

A total of 133 systems have been replaced to date.





Feral Hog Abatement Efforts

TDA Grants

- Coryell/Hamilton
 County
- 2012-2017
- \$77,000
- Bounty Programs
- Trapping supplies purchased





Future Feral Hog Abatement Efforts

- Estimates are now at 4-5 million hogs in state
- Original TMDL estimated 28k hogs in watershed
 - Population has more than likely doubled or tripled since that time
- Coryell Co. will continue trapping program
- Wildlife Services feral hog trapper
- Additional funding sources???



WQMP Grant

- Landowners within the Leon River Watershed are eligible
- Collaboration with NRCS
- Up to \$15,000 per application
- Estimated 60% cost share



WQMP Implementation

- Total Plans 15
- Total Funding \$111,842
- Total Acres 4,791
- Additional 13 plans and \$155,000 spent since September***







Coryell County-NRCS

• (excluding Ft. Hood)











Hamilton County-NRCS

- Watershed = 45% of county









Comanche County-NRCS
