The Brazos River Authority (BRA) informed you by letter of the declaration of the Stage 1 – Drought Watch for the Lake Georgetown – Stillhouse Hollow (SH-GT) reservoir sub-system dated March 17, 2022. The BRA also informed you by letter of the declaration of a Stage 1 – Drought Watch dated July 20, 2022, for the 25,000 acre-feet (AF) of water (Lower Colorado River Authority (LCRA) water) that BRA has contracted with the LCRA to be delivered from the Colorado River Basin for use in Williamson County. Finally, the BRA informed you by letter of the declaration of the Stage 2 – Drought Warning for the SH-GT reservoir sub-system dated August 4, 2023.

You are receiving this letter because you have a water supply contract with the BRA for a portion of the LCRA water, and continued drought conditions in the Colorado River Basin have resulted in the combined storage of Lakes Buchanan and Travis dropping below the Stage 2 – Drought Warning storage trigger of 900,000 AF. **Therefore, the BRA is implementing a Stage 2 – Drought Warning Condition for customers using LCRA water.**

As stated in the BRA Drought Contingency Plan (Plan), BRA will comply with LCRA drought declarations for this water. Under Stage 2, LCRA is requesting a ten to twenty percent (10-20%) reduction in water use that would have occurred in the absence of any drought contingency measures.

**We ask that you take action consistent with the BRA Plan and LCRA's Stage 2 drought declaration to achieve a ten to twenty percent (10-20%) reduction in water use.**
